- 1. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Earnest Partners, LSV, Lyrical Partners and Clearbridge (Equities) for the month ending December 2023.
- 2. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve all other investment transactions executed in-house thus far for January 2024.
- 3. On a motion by Member Downey and second by Member J. Saunders, the BCRB voted unanimously to approve the Investment Summary Statement for month ending December 2023 as reported to the BCRB by our custodial bank (Wilmington Trust); and a year-to-date performance.
- 4. Segal Marco Advisors reviewed the preliminary asset allocation summary and benchmark returns as of January 24th. Fund assets stand at \$894.7 million, up about \$4 million since last month net of withdrawals. High level composite allocations are as follows:
 - Equity is underweight (-1.2%) and private equity is overweight (+2.2%)
- Fixed income and hedge funds are underweight (-0.9% and -0.8%, respectively) and real estate/hard assets are overweight (+0.5%)
 - Cash is ~\$1.0 million (0.1%)

Composite and manager allocations are close to target, however, given future payroll and capital call needs, Segal Marco recommends taking some gains from domestic equity and adding to cash and fixed income as follows:

- -\$2 million Northern Trust Russell 1000 Growth
- -\$2 million Columbia Large Growth
- -\$2 million LSV Large Value
- -\$2 million Lyrical Large Value
- -\$1 million Earnest Small Value
- -\$1 million Frontier Small Growth
- +\$8 million Cash
- +\$2 million Northern Trust Bond

On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the recommendation.

EARNEST PARTNERS Presenter: Trey Greer

Mr. Greer thanked the BCRB for their long-term partnership. He provided a firm and fund overview. Fund performance for 1-year (as of 12/31/23) was 16.05%. Since inception (4/30/2003), the fund's performance has been 11.1%.

FRONTIER Presenters: Peter Kuechle, Drew Bennett and Greg Mulready

They provided a fund and firm overview. The funds 1-Year (as of 12/31/23) return was 24.0%. Since inception (12/3/2018), the fund's performance has been 10.0%.
