### INVESTMENT AND FINANCIAL DISCUSSION

On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve the most current bank reconciliations for October 2023 and the expense, refund and transfer vouchers as follows:

- 1. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Earnest Partners, LSV, Lyrical Partners and Clearbridge (Equities) for the month ending October 2023.
- 2. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve all other investment transactions executed in-house thus far for November 2023.
- 3. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve the Investment Summary Statement for month ending October 2023 as reported to the BCRB by our custodial bank (Wilmington Trust); and a year-to-date performance.
- 4. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to receive and place on file Segal Marco Advisors Investment Fee Review report.
- 5. Mr. Procek reviewed the asset allocation summary and benchmark performance as of November 20<sup>th</sup>. Assets are up approximately \$26 million since last month to \$880.6 million. Month-to-date, all major equity indices are up high single digits and fixed income is up 3-4%. High level allocations are as follows:

- Equity is underweight (-3.1%) and private equity is overweight (+2.4%)

- Fixed income and hedge funds are underweight (-1.4% and -0.9%, respectively) and real estate/hard assets are overweight (+1.3%)

- Cash is ~\$14.7 million (1.7%)

Segal Marco Advisors continue to recommend holding cash for payroll and capital call needs and do not recommend rebalancing. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve the recommendation.

Mr. Procek updated the BCRB that the PIMCO Emerging Market Debt documents and side letter are now ready to be signed. They are recommending an initial \$16 million investment based on the target allocation. Funding will come almost entirely from the liquidation of Ashmore and Stone Harbor.

On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously (Rivard-aye, Downey-aye, J. Saunders-aye, DeFontes-aye and Chairman Saunders-aye) to approve the recommendation.
