Segal Marco Advisors Financial Consultants

On the call: Marc Procek and Kevin Roundtree-Segal Marco Advisors

- 1. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously by roll call vote (Rivard-aye, Downey-aye, J. Saunders-aye and Chairman Saunders-aye) to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Earnest Partners, LSV, Lyrical Partners and Clearbridge (Equities) for the month ending July 2022.
- 2. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously by roll call vote (Rivard-aye, Downey-aye, J. Saunders-aye and Chairman Saunders-aye) to approve all other investment transactions executed in-house thus far for August 2022.
- 3. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously by roll call vote (Rivard-aye, Downey-aye, J. Saunders-aye and Chairman Saunders-aye) to approve the Investment Summary Statement for month ending July 2022 as reported to the BCRB by our custodial bank (People's United); and a year-to-date performance.
- 4. Segal Marco Advisors provided the preliminary 2nd quarter report along with an updated allocation summary and month-to-date benchmark performance through 8/19. The Fund's -7.7% return for the quarter outperformed the Plan Index and Allocation Index by 3.3% and 2.4%, respectively. The Fund's -9.8% return year-to-date outperformed the Plan and Allocation Indices by 5.1% and 3.3%, respectively. These returns rank high first quartile vs. public fund peers. Total Fund performance is subject to some revision as underlying managers representing about 9% of total market value have yet to report 2nd quarter returns. They do not expect returns to change materially though as positive returns from outstanding real estate, timber and infrastructure investments are anticipated to be offset by negative returns from private equity managers.

In regard to the allocation, Segal Marco Advisors does not recommend any rebalancing this month. Last month's recommendation to invest \$10 million in both the NT S&P 500 and NT US Aggregate index funds brought us closer to targets while maintaining some small underweights to equity and fixed income. These underweights are offset by private equity and real estate overweights, and approximately \$28 million in cash (about \$10 million of which will be called for Ceres Farmland and Terracap V within the next two weeks). Segal Marco Advisors recommends holding this remaining cash for payroll and capital call needs over the next couple of months.

On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously by roll call vote (Rivard-aye, Downey-aye, J. Saunders-aye and Chairman Saunders-aye) to approve the recommendations.

Mr. Procek reminded the BCRB that Investment RFPs will commence, as we approach the seven year required renewals. Emerging Market Debt, Infrastructure and Large Cap Growth will be the first three asset classes.

INVESTMENT MANAGER REVIEWS:

CERES PARTNERS

Presenters: Barbara Keady and Brandon Zick

They provided a firm update. Ms. Keady reviewed the reasons to invest in farmland, with historically strong returns and low volatility. Farmland has proven an effective diversifier-especially during major drawdowns in U.S. Equities. Acquisition Activity was reviewed. We funded July 1, 2020. For Calendar year 2021, the return was 13.83%. YTD 2022, the return was 10.76%.

GOLDENTREE

Presenters: Brendan McDonough, Partner and Abigail Glerum, Managing Director

Mr. McDonough provide a firm overview. They reviewed the assets under management. Goldentree has deliberately positioned the MA Multi-Sector Fund to have a large exposure to high quality senior secured investments. The returns for YTD 2022 have been -2.95%. They reviewed investment examples.

BTG PACTUAL

Presenters: Jim McBride, Relationship Manager and David Cassels, OEF Portfolio Manager

They provided an Executive Summary of the Firm. The fund has generated a net IRR of 11.3% and a net MOIC of 1.15X. An overview of the portfolio construction and U.S. Timberland exposure by region was provided.

HANCOCK

Presenters: Amy Haynes and Julie Koeninger

They provide a firm overview and the portfolio development. Ms. Haynes reviewed the historical performance and projected cash yield. The Net 1 Year Return as of 6/30/22 was 3.5%. The Net QTD Return was -.03%. Ms. Koeninger reviewed the drivers of timberland and agriculture investment in current climate.
