INVESTMENT AND FINANCIAL DISCUSSION

Segal Marco Advisors Financial Consultants

In attendance: Marc Procek and Kevin Roundtree

- 1. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Earnest Partners, LSV, Lyrical Partners and Clearbridge (Equities) for the month ending January 2020.
- 2. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve all other investment transactions executed in-house thus far for February 2020.
- 3. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the Investment Summary Statement for month ending January 2020 as reported to the BCRB by our custodial bank (People's United); and a year-to-date performance.
- 4. Cash flow needs for March were discussed. Mr. Procek recommended to raise \$3.0 million from the Income Research Management-TIPS Portfolio and \$4.0 million from PIMCO Diversified Income. On a motion by Member Rivard and second by Member John Saunders, the BCRB voted unanimously to approve the recommendation of Mr. Procek.
- Mr. Procek recommended to raise \$8.0 million from the PRIT Absolute Return Strategy for the 2nd Quarter distribution deadline. The settlement date would be April 1, 2020. On a motion by Member Downey and second by Member John Saunders, the BCRB voted unanimously to approve the recommendation of Mr. Procek.
- 5. Mr. Roundtree reviewed the responses to the Diversified Timber and Farmland RFP. Seven (7) firms submitted proposals. After discussion, on a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to proceed with Four (4) firms for further research. The firms will be BTG Pactual, Ceres Partners, Hancock and UBS. Segal Marco will present the results at the March meeting.
- 6. Mr. Procek reviewed the 4th Q 2019 Performance Report. The preliminary numbers indicate a gross return in the 17% range. On a motion by Member Downey and second by Member John Saunders, the BCRB voted unanimously to receive and place on file.

STONE CONSULTING

Lawrence Stone and Colin Edgar presented to the BCRB what the process will be for the January 1, 2020 Actuarial Study. They will work with the Board to develop assumptions that are agreed upon. They will continue to work on the data and report back with their finding and options.

Conference Call: Kevin Pope, Product Management and Gina Lenzi Domaoal, Associate Director

Mr. Pope provided a firm and equity market overview. The global equity markets were generally positive in the fourth quarter 2019. The 1 year performance as of December 31, 2019 was 25.83%. There is uncertainty with the coronavirus. Fund performance, asset growth since inception and sample holdings were all discussed. They are staying true to their investment process.

Conference Call: Matthew Harrington, Director, Institutional Services and Sara Dudley

Mr. Harrington reviewed the firm and where Intercontinental stands today. They reviewed of the properties in the portfolio. The returns since inception (1/12/2017) have been 9.83%. The returns through 12/31/19 are 9.47%. They reviewed the breakdown of property types and the statistics in each category (number of properties, occupancy rates, etc.).
