INVESTMENT AND FINANCIAL DISCUSSION

Segal Marco Advisors Financial Consultants

In attendance: Marc Procek and Kevin Roundtree

- 1. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Arrowstreet Capital, Earnest Partners, LSV, RiceHallJames, Trust & Fiduciary Services, Lyrical Partners (Equities), and CBRE Clarion (Real Estate) for the month ending July 2018.
- 2. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve all other investment transactions executed in-house thus far for August 2018.
- 3. On a motion by Member Rivard and second by Member John Saunders, the BCRB voted unanimously to approve the Investment Summary Statement for months ending July 2018 as reported to the BCRB by our custodial bank (State Street Bank and Trust); and a year-to-date performance.
- 4. Mr. Procek provided the BCRB with the search book for the Custodial Bank Search. Three (3) firms submitted responses: State Street Bank, Comerica Bank and People's United Bank. After review and discussion, on a motion made by Member Rivard and second by Member Downey, the BCRB voted unanimously to interview all three (3) firms. The interviews will take place at the September meeting.
- 5. As the Fiscal Year 2019 Appropriations have been received, Mr. Procek recommended investing \$20 million as follows:

\$10 million in Emerging Markets Equity: \$5 million to Lazard and \$5 million to Aberdeen. On a motion by Member Downey and second by Member Rivard, the BCRB voted unanimously to approve the recommendation.

\$10 million to Fixed Income: \$5 million to PIMCO, \$2.5 million to Stone Harbor and \$2.5 million to Ashmore. On a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to approve the recommendation.

MANAGER REVIEWS:

All presentation booklets were provided ahead of the meeting.

INVESCO

Presenters: Rivka Altman Portfolio Manager and Robert Moriarty Jr., Relationship Manager

Mr. Altman reviewed the performance of Fund I and II. Fund I is in disposition phase and they anticipate fund-level returns of 18.4% gross IRR. Full liquidation of private CRE investments expected by year end 2018. Over 100% of contributed capital has been returned. Fund II (Vintage Year 2014) portfolio holdings/construction were reviewed. 26% IRR/1.6x EM within the three year investment period, with capital being redeployed. They are anticipating up to four unrealized assets being realized by the end of 2018.

BLACKROCK

Presenters: Meredith Moran and Amy Park, Vice President

Ms. Moran reviewed the firm, the investment team and the investments of each Fund. This is a top down strategy with only quality investments. 87% of capital has been called to date, which they do not anticipate any further calls. Distributions to paid in capital ratio is 1.22x, however total value to paid in capital ratio is 1.48x. For Fund IV, 89% of capital has been called. Blackrock is consistently making distributions. To date, distributions to paid in capital ratio is .93x, however total value to paid in capital ratio is 1.59x. Gross IRR since inception is 11.4%.

COLUMBIA

Presenters: Joseph Dougherty, Relationship Manager and Paul Shelton, Client Portfolio Manager

Mr. Dougherty reviewed the firm's investment philosophy. Columbia's objective is to identify companies gaining market share in industries that are gaining wallet share as a percentage of GDP. They reviewed the current portfolio and the performance. YTD is 10.86% versus benchmark of 7.25% and 5 Year is 16.16% versus benchmark of 16.36%. The Top 5 Contributors and detractors were reviewed.

DN PARTNERS

Presenter: John Dancewicz

Mr. Dancewicz reviewed that after a series of cost cuts in recent years, M&M Pump and Chinada are both performing in line or better than plan. Further cost controls are being implemented to try to improve results and achieve profitability for M&M Pump. Chinada represents over 80% of the remaining value in the fund and has seen strong sales and profitability growth in the past year. Formal valuations are performed annually and write-ups on both companies are expected if the companies continue to perform to plan.
