The Bristol County Retirement Board reviewed and approved the most current bank reconciliations and the expense, refund and transfer vouchers.

INVESTMENT AND FINANCIAL DISCUSSION

Segal Marco Advisors Financial Consultants

In attendance: Marc Procek and Michaela Pastore

- 1. On a motion by Member Downey and second by Member Rivard, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Arrowstreet Capital, Earnest Partners, LSV, RiceHallJames, Trust & Fiduciary Services, Lyrical Partners (Equities), and CBRE Clarion (Real Estate) for the month ending May 2017.
- 2. On a motion by Member Downey and second by Member Rivard, the BCRB voted unanimously to approve all other investment transactions executed in-house thus far for June 2017.
- 3. On a motion by Member Downey and second by Member Rivard, the BCRB voted unanimously to approve the Investment Summary Statement for months ending May 2017 as reported to the BCRB by our custodial bank (State Street Bank and Trust); and a year-to-date performance.
- 4. On a motion by Member Downey and second by Member Rivard, the BCRB voted unanimously to receive and place on file a Memorandum (#18-2017) dated June 7, 2017 from Thomas J. O'Donnell, Compliance Officer, of PERAC, to the BCRB regarding an updated Tobacco Company List.
- 5. Mr. Procek provided search booklets on the remaining four (4) Value Manager and four (4) Growth managers. After discussion, on a motion by Member Rivard and second by Member Downey, the BCRB voted unanimously to interview ClearBridge Investments, Columbia Management and INTECH Investment Management for Growth and Eagle Capital Management, LSV Asset Management and Lyrical Partners for Value. The interviews will be at the regularly scheduled Board meeting on July 26, 2017.

MANAGER REVIEWS:

BLACKROCK VESEY STREET PRIVATE EQUITY FUNDS III AND IV

Conference call: Mitchell King, Director and Dylan Herman, Analyst

This is a top down strategy with only quality investments. Fund III recovered well especially since the fund was started in 2006. 87% of capital has been called to date, which they do not anticipate any further calls. Distributions to paid in capital ratio is 1.12x, however total value to paid in capital ratio is 1.40x. For Fund IV, 88% of capital has been called. Blackrock is consistently making distributions. To date, distributions to paid in capital ratio is .75x, however total value to paid in capital ratio is 1.51x. Gross IRR since inception is 11.2%.

DN PARTNERS

Conference call: John Danciewicz, CEO

Mr. Danciewicz explained that the collapse of the oil market is the main contributor to the funds loss in M&M Pump and Supply. They are developing relationships with new customers and continue to reduce costs. They are expanding in Ohio and now have three (3) major customers, up from one (1) last year. Until there is a rebound in the oil market, the fund will continue to lose money. If the market rebounds, the margins will be rather favorable. For the Chinada Holdings, improvements are being made to grow the company. Mr. Danciewicz hopes that they will be in a position to sell both companies within the next two (2) years. He is hopeful that the BCRB will receive a return on their investment, with some excess return. Mr. Rivard expressed his discontent to Mr. Danciewicz regarding the poor performance of this investment.

PIMCO

Conference call: Yinyin Wu, Vice President and Priya Bishen, Account Manager

They reviewed the firm focus of managing risk and delivering returns. An update on firm assets under management was highlighted. Performance for year to date Net of Fees is 5.8% which beat benchmark by 2.4%. The 1 year returns net of fees is 11.1%, compared to the Benchmark of 5.8%. Underweight in raw materials and Asia EM were the biggest detractor in Quarter 1. While tactical exposure to non-Agency MBS, exposure to Mexican and Brazilian external debt and U.S. duration positioning was the largest contributors. They reviewed their positioning and Outlook.
