The Bristol County Retirement Board reviewed and approved the most current bank reconciliations and the expense, refund and transfer vouchers.

INVESTMENT AND FINANCIAL DISCUSSION

Segal Marco Advisors Financial Consultants

In attendance: Marc Procek and Michaela Pastore

- 1. On a motion by Member John Saunders and second by Member DeFontes, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Arrowstreet Capital, Earnest Partners, LSV, RiceHallJames, Trust & Fiduciary Services, Lyrical Partners (Equities), and CBRE Clarion (Real Estate) for the month ending April 2017.
- 2. On a motion by Member John Saunders and second by Member DeFontes, the BCRB voted unanimously to approve all investment transactions executed in-house thus far through May 2017.
- 3. On a motion by Member John Saunders and second by Member DeFontes, the BCRB voted unanimously to approve the Investment Summary Statement for months ending March and April 2017 as reported to the BCRB by our custodial bank (State Street Bank and Trust); and a year-to-date performance.
- 4. Mr. Procek and Ms. Pastore reviewed with the BCRB the responses from the Domestic Equity Searches. For Large Cap Growth, nineteen (19) firms responded, of which ten (10) are rated by Segal Marco Advisors as Highly Advantageous or Advantageous. After discussion, on a motion by Member John Saunders and second by Member DeFontes, the BCRB voted unanimously to have further research provided for ClearBridge Investments, Columbia Management, INTECH Investment Management and William Blair Investment Management. For Large Cap Value, twenty-seven (27) firms responded, of which eight (8) are rated by Segal Marco Advisors as Highly Advantageous or Advantageous. After discussion, on a motion by Member John Saunders and second by Member DeFontes, the BCRB voted unanimously to have further research provided for Cooke & Bieler, Eagle Capital Management, LSV Asset Management and Lyrical Partners. The information will be provided at the June 28th Board meeting.
- 5. Mr. Procek reviewed the investment manager search schedule. Global Real Estate Investment Trusts will be the next search. The mandate will be approximately \$10-15 million. The Board directed the Executive Director to post the RFP on the PERAC website.
- 9. On a motion by Member John Saunders and second by Member Downey, the BCRB voted unanimously to approve the extension to GCM Grosvenor Customize Infrastructure Strategies of the Final Admission Date to May 31, 2017, from March 31, 2017.

MANAGER REVIEW:

RBC INTERNATIONAL

Conference call: Ashley Hyotte, V.P., Institutional Portfolio Manager and Emily Moran, Associate Portfolio Manager

Ms. Hyotte reviewed the investment objective and philosophy. For Calendar year 2016, RBS had a total return of 6.75% versus the benchmark of 1.51%. YTD 2017, the total return of 10.63 versus the benchmark of 10.20%. For the collective periods of the 3, 5, 10, 15, and 20 year measurement periods they have beaten the benchmark. As an international equity manager, she reviewed the current investment climate in Europe, Asia and Africa. She highlighted the five largest contributors to the TYD 2017 performance with the information technology sector having the best performance, up 14.1% YTD. Noting the five largest detractors, with the energy sector with the weakest performance, down 2.6% YTD. They continue to search for high quality companies trading at an attractive valuation to add to the portfolio.

RREEF AMERICA REIT II FUND

Conference call: John Ehli, Co-Lead Portfolio Manager, Cameron Dowe and Noelle Toney

Mr. Ehli provided a firm update and reviewed the Year to date 2017 highlights. Firm assets are now at \$54.6 billion. Performance is doing well over benchmark on gross basis for trailing 1,3,5,10,20 and 30 years. There has been a 5.6% annual dividend yield since inception. This fund has never missed a quarterly dividend payment to shareholders. Mr. Dowe reviewed the diversification, holdings and portfolio concentration. The target for 2017 is 6-8% Fund Total Return. Their 3 year and 5 year returns are 13.6% and 12.3% respectively and 11.3 and 11.8 respectively, net of fees. We currently reinvest all dividends in this core holding. RREEF remains dedicated to disciplined investment execution.
