The Bristol County Retirement Board reviewed and approved the most current bank reconciliations and the expense, refund and transfer vouchers.

INVESTMENT AND FINANCIAL DISCUSSION

Segal Marco Advisors Financial Consultants

In Attendance: Marc Procek and Michaela Pastore

- 1. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to approve the investment transactions that were executed by Income Research and Management, Inc. (Fixed Income) and Arrowstreet Capital, Earnest Partners, LSV, RiceHallJames, Trust & Fiduciary Services, Lyrical Partners (Equities), and CBRE Clarion (Real Estate) for the month ending September 2017.
- 2. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to approve all other investment transactions executed in-house thus far for October 2017.
- 3. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to approve the Investment Summary Statement for months ending September 2017 as reported to the BCRB by our custodial bank (State Street Bank and Trust); and a year-to-date performance.
- 4. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to receive and place on file a memorandum (#32-2017) dated October 6, 2017 from Thomas J. O'Donnell, Compliance Officer, of PERAC, to the BCRB regarding an updated Tobacco Company List.
- 5. Mr. Procek presented research books for Small Cap Growth and Value Managers. For Value, Pzena appears more volatile and with the highest fees. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to interview Earnest Partners and Fisher Investments. For Growth, Rice Hall James performance has been lacking compared to peers. On a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to interview Frontier Capital Management Company and Wasatch Advisors, Inc.
- 6. Mr. Procek addressed concerns regarding change of ownership for Centersquare in the REIT's Search. After review and discussion, on a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to replace CBRE Clarion and hire Brookfield for \$10 million investment. The new investment period with Brookfield Private Advisors will not exceed seven (7) years from funding date.
- 7. Mr. Procek provided the search criteria for the next RFP search for International Core, Growth & Value Equity. Bids will be due November 29th. The Board asked the Executive Director to post the RFP to the PERAC website.
- 8. A new RFP search for Value-Add/Opportunistic Real Estate Managers will be conducted after the International Search.
- 9. The BCRB reviewed the Retention Agreement submitted by Labaton Sucharow LLP in litigation against Ubiquiti Networks. Chairman Saunders had one correction to make in the agreement. With the amendment made, on a

motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to approve the agreement.

10. The BCRB reviewed the Retention Agreement submitted by Labaton Sucharow LLP in litigation against Ubiquiti Networks. Chairman Saunders had one correction to make in the agreement. With the amendment made, on a motion by Member Rivard and second by Member J. Saunders, the BCRB voted unanimously to approve the agreement.

MANAGER REVIEWS:

INCOME RESEARCH

In Attendance: Matt Drasser, Senior Vice President and Mike Sheldon, Senior Portfolio Manager

Mr. Drasser reviewed the firm updates and assets of the firm. Our Fixed Income account is up 3.98% for the year versus 3.49% for the Barclay's benchmark. Our TIPS account is up 1.39% versus 1.36% for the benchmark. IRM is comfortable with their exposures and believe their portfolio will benefit from a high-quality, domestic focus. Mr. Sheldon explained the benefits of being overweight in Securitized Bonds.

STONE HARBOR INVESTMENT PARTNERS LP

Conference Call: John Madden, Partner, Client Relationship Manager

Presentation booklets were provided prior to the meeting. Mr. Madden reviewed the firm update and assets of the firm. The Collective investment trust structure was reviewed. In the year since funding began, the portfolio is up 8.67% compared to the index of 7.29%. YTD, the portfolio is up 13.23% compared to the index of 11.61%. The largest contributor was to hard currency sovereign allocation. Mr. Madden reviewed the Emerging Markets Outlook, addressing the major risk factors. The projected index spreads and total returns were reviewed.

LAZARD

Conference call: Frank Sposato, Director, Monika Shrestha, Director, Portfolio Manager/Analyst and Stephanie van Hengel

Presentation booklets were provided prior to the meeting. Mr. Sposato reviewed the investment philosophy and process for this emerging market investment. Ms. Shrestha reviewed Lazard's investment philosophy and objectives. Lazard focuses on companies that are financially productive and inexpensively valued. Ms. Shrestha reviewed the key observations for YTD 2017 noted that they have underperformed lately compared to index due to environmental issues. They are keeping with their Relative Value Strategy and do not invest just because certain market classes gain momentum. They reviewed the portfolio content and the most recent transactions and profiles of their largest holdings. YTD as of September 30, 2017, the returns net of fees were 20.00% versus Index at 27.78%.
